In exchange for the consideration of my job application by the Boys & Girls Clubs of Denton County, Inc. (hereinafter called "the Company"), I agree that:

I hereby give the Company permission to contact schools, previous employers (unless otherwise indicated), references, and others, and hereby release the Company from any liability as a result of such contact.
